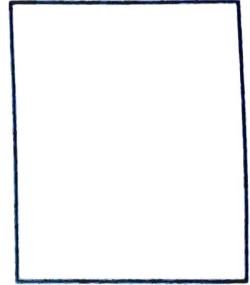

Terms & Conditions of Membership

1. Any person(s), above 18 years of age, desirous of becoming a Member of Airoli Bengali Association shall apply in the prescribed format, as given overleaf, along with Membership fee of Rs. 2250.00 (including Entry fee of Rs.150.00) and two recent stamp size photographs.
2. The Introducer must be a Life Member of Airoli Bengali Association.
3. The Membership is subject to the approval of the Managing Committee of the Association which reserves the right to accept / reject any Application.
4. If any Application for membership is approved by the Managing Committee, then the Applicant will be considered as Provisional Life Member.
5. In case, any Application is turned down by the Managing Committee due to any reason what so ever, the Application fee of Rs. 2250.00 & the two photographs will be returned to the Applicant.
6. Any Provisional Life Member may become a Life Member of Airoli Bengali Association after successful completion of 2 years from the date of becoming Provisional Life Member with due approval from the Managing Committee.
7. The probation period of 2 years may be extended by the Managing Committee in the event of un-satisfactory performance of any Provisional Life Member.
8. In case, any Provisional Life Member indulges in activities detrimental to the interest of the Association, his/her Provisional Life Membership may be terminated by the Managing Committee .
9. In the event of termination of Provisional Life Membership, Rs. 2100.00 will be refunded without interest .
10. The Provisional Life Members may participate in all the activities of the Association and enjoy all the facilities/benefits etc., except the voting right.
11. Provisional Life Members are not entitled to vote either in the General Body Meeting or in the selection / election of Managing Committee or in any other voting of the Association . Only Life Members are eligible to vote.
12. All the Members shall abide by the rules & regulations of the Association and follow the advice / instructions of the Managing Committee issued from time to time.
13. The Life Membership may also be terminated if any Member is convicted by the court of law or found indulging in anti Association activities.
